NCCS has been performing basic and fundamental research in the areas relevant to human health and diseases using appropriate cell based or small animal models.

The institute is looking for a Consultant (Scientific) from Indian nationals to strengthen the ongoing areas of interdisciplinary research. NCCS invites applications from superannuated Scientists /or those Scientists who are due for superannuation in the next six months. In this direction, NCCS is seeking applications from eligible candidates to specifically contribute towards the interface of basic and public health research in the domains of metabolic diseases and Cancer with a provision for exploring translational application for fundamental research. **The last date of receipt of applications is 21.08.2022.**
