You can add further container experience as an added advantage. Being very big organization with many BLS3 labs which were certified by DBT, we are unable to participate with the terms used in this bid which favors only few Bidders. Bidder requested If prequalification criteria changes, we can participate, otherwise not.	NCCS clarified that the nature of BSL3 facility under the contract is highly specialized type of work and due to limited availability of space, will require high-level of customization. Consequently, it is crucial for the bidder to possess specific experience of establishing containerized or mobile BSL-3 Lab units, as this experience and expertise is essential for efficiently designing and fitting all required equipment, services and utilities within the available space, in compliance with National and international guidelines.
